## OPZZ and Unions21 Collaboration on the TUDO Project: The Second Networking Meeting Behind Us!

We are pleased to inform you that the second meeting in the framework of the OPZZ and Unions21 collaboration on the TUDO project took place on January 17th, 2025. This meeting, led by Nick Scott, Director of the Unions21 Centre for Responsible Union AI and Digital Transformation, marked an important step in the development of modern organizational tools and digital solutions aimed at strengthening the effectiveness of trade unions in supporting their members.

Nick Scott, a consultant with over twenty years of experience working with non-profit organizations and trade unions, shared his expertise on artificial intelligence (AI) and its applications in the context of union work. His experience includes collaborating with organizations such as UNISON, MSF, Greenpeace, and Concern Worldwide, helping them navigate digital transformations and implement innovative AI-driven solutions.

## Meeting Overview:

The session, titled "Responsible AI Fundamentals", aimed to introduce participants to the fundamental principles of AI and its relevance to trade union work. Participants gained practical skills in utilizing AI in the daily operations of their organizations.

### 1. Basic AI Concepts

Nick Scott introduced participants to the fundamental concepts of AI, explaining why artificial intelligence is becoming a key tool in the work of trade unions. Examples were presented on how AI can support organizational management, increase process efficiency, and influence union activities.

### 2. Application of AI in Union Work

Participants had the opportunity to explore case studies showing how AI can impact trade union operations. The discussion focused on how AI can improve work quality, streamline communication with members, and enhance organizational processes.

### **4. Ethical and Responsible Use of AI**

A key point of discussion was the responsible use of AI technologies. Participants were guided on how to evaluate AI tools and implement them in an ethical manner, keeping in mind the values of trade unions and the well-being of their members.

The meeting with Nick Scott was another step toward implementing modern digital tools in the work of trade unions. Thanks to this, the TUDO project is gaining momentum, providing participants with practical tools that can be applied in their daily activities.
